11. Entertainers are responsible only for their own conduct. Purchaser assumes all risk of the engagement and shall indemnify and hold entertainer harmless against any claims or legal actions brought against Entertainer arising out of personal injury or property damage occurring at the engagement which is not caused by the Entertainer.
12. Purchaser agrees that in all circumstances, Entertainers liability shall be exclusively limited to an amount equal to the performance fee and that Entertainers shall not be liable for indirect or consequential damages arising from any breach of contract.
13. Purchaser is responsible for paying any charges imposed by the venue.
14. Acceptance. The terms and conditions of this contract are hereby accepted by the Purchaser and Entertainer. The terms of this contract are binding and supersede any oral or written representations.
